III. Content of the course

1. Abstract of the course

The problem of the fastest possible reconstruction and diversification of the development of urban and rural communities of Ukraine has been on the rise since the first days of the war. The issue of the development of territorial communities is extremely acute, given the forced migration of the population from war-torn regions to safer ones and their involvement in community life. Studying the experience of the countries of the European Union in matters of decentralization of management and finances, achieving the prospects of sustainable, inclusive, smart development of cities and rural areas is important for Ukraine. Especially the experience of those countries and regions that have already passed similar tests at one time.

2. Purpose and objectives of the course

The purpose of the course is to study the experience of the countries of the European Union in matters of decentralization of management and finance, achieving the prospects of sustainable, inclusive, smart development of cities and rural areas is important for Ukraine, and analyzing the possibilities of its adaptation in modern conditions of Ukraine.

The objectives of the course are to study the content and structure of EU regulatory policy, EU policy, and experience in regulating decentralization processes and local development, and EU experience in sustainable, inclusive, and smart development of cities and rural areas.
